The event was opened with a brief overview of the College by the Chief of Staff, Captain Mark Hardwick RN. It is a logistics centre of excellence that more members should try and see - with 460 course types comprising an astonishing 23,566 course places last year! With some 300 logistic training staff, there is not only an absolute wealth of operational experience in the College, but it is also an extremely fertile source of potential CILT members amongst the trainees.

Almost as an aside, Chris Markey gave a presentation on the use of Artificial Intelligence and Machine Learning in supply chain operations, with examples from

across industry and retail sectors. Members can view a recording of the presentation and an overview of DCLPA on the Community website, but Q&A and extended discussions were not recorded - you had to be there to hear the frank, open views expressed by the Defence experts!

Current CILT members were able to interact with military logistics trainees and directing staff during the presentation, where the benefits of CILT membership were discussed, and massively reinforced with 'case studies' of career progression with the Institute from Simon Harris CMILT and Adrian Percival CMILT from TVG. We all really enjoyed mixing socially with our military hosts both before and after the formal presentation. Over fifty military attendees benefited from the event, and many took membership forms away (but TVG are not planning to claim their referral bonuses!)

Our members came predominantly from TVG and Hants & Dorset Groups, but one member.
